- Your application must be received by CS&PF by no later than 30th April, failing which your application will be invalid.
- Individuals who wish to swim in this relay should apply online by submitting a Membership form and uploading their completed, signed and scanned Medical and Assessment Swim forms. For Membership forms please visit <http://cspf.co.uk/membership>. These forms must be completed no later than 14 days before this relay tide start date.
- Alternatively, individual Membership and Assessment Swim forms can be emailed to office@cspf.co.uk no later than 14 days before this relay tide start date.
- The CS&PF shall not be obliged to accept any change to the team manager/captain nor to accept any form or communication in relation to this application from any team member other than the team manager/captain. Notice given by the CS&PF to the team manager/captain shall be deemed to be notice to every team member.
- Any decision by the CS&PF to review an incomplete application or not received until after 30th April, shall not change the status of your application, which shall remain invalid unless subsequently confirmed as valid in writing by the CS&PF in its discretion.
- The CS&PF shall notify you if your application is invalid and the reason(s) for this and may (but shall not be obliged to) return any invalid application; following such notification, the CS&PF shall not be obliged to enter in to further correspondence.
- Exercise by the CS&PF of its discretion for one applicant won't imply any relaxation of that requirement for any other person and the exercise of discretion may be subject to the levying of an administrative charge.
- By submitting this form you accept that the decision of the CS&PF on the issue of the validity of your application, is final and binding and that (in the CS&PF's discretion) all or part of your administration fee shall be non-refundable.
- The CS&PF reserves the rights to publish all successful swim details including name, age, gender & nationality of swimmers involved.
